Vendor will submit complete set of Drawings in 14 working days from the date of receipt of confirmed PO from M/S MRPL.	Drawing submission for approval - within 14 days of release of order.  Material delivery at site - Within 24 weeks of approval of drawing and manufacturing clearance.
3	Security Deposit @ 3%:- We will deposit EMD amount & 3% PBG and hence security deposit in addition to these two is not envisaged. Please provide waiver for security deposit.	Tender terms shall prevail.
4	Price Reduction Schedule: It's not applicable to us and hence can't be accepted.	Tender terms shall prevail.
5	Due date extension	Last date & time to submit the bid is extended to 15:00 HOURS (IST) ON 12-Dec-2022.
