1. The bids will be finalized based on item / lot wise H1 basis.
2. The Evaluation of bids shall be done on lot-wise H1 Basis as per the details quoted in unpriced bid and price Bid as mentioned below:

Total evaluated price (which is the Bid submission price) = (Evaluated Price per kg per lot of spent catalyst \* net weight of spent catalyst in kg per lot)

Basis for calculation of spent catalyst evaluation price per Kg of Spent catalyst is

$$\left[ P \times \left( \frac{M}{100} \right) \times \{ (100 - L) \div 100 \} \times \left( \frac{N}{100} \right) \right] + (\pm Q \times P)$$

Where

**P : Platinum rate per kilogram** = Average of LME Fix Platinum price AM & PM converted to per KG for the previous seven days ending one day prior to the price bid opening date . (Seven days shall mean consecutive seven days for which LME prices are available);

**L : Loss on Ignition** % by weight as per bidder's analysis;

**M : Platinum Content** in % by wt of spent catalyst excluding LOI as per bidder's analysis;

**N : Expected recovery** % by wt as per bidder's analysis

**Q : Premium/Discount** as percentage of Platinum price (P): Indicate Plus (+) or Minus (-) as the case may be [where (+) positive indicates additional premium being offered by the bidder and (-) negative indicates lesser than the rate offered which may include the processing cost etc.

LME Platinum price in USD per troy ounce would be converted to rate per gram using conversion factor of 1 troy ounce=31.1035 grams. This will be converted to Per Kg.

For comparative evaluation USD /EURO would be converted to INR using USD-INR Exchange rate prevailing at the time of price bid opening, which would be considered on the basis of the reference rate of Reserve bank of India (as available on RBI/FBIL website) on the day prior to price bid opening date.
