EXPRESSION OF INTEREST (EOI) FOR
OPERATION & MAINTENANCE OF MATERIAL RECOVERY FACILITY (MRF)

1.0 BACKGROUND:

Mangalore Refinery & Petrochemicals Limited (MRPL), a Government of India - Schedule-A CPSE and a subsidiary of Oil and Natural Gas Corporation Limited (ONGC), is operating a 15 MMTPA Refinery Complex in Mangalore, Karnataka state.

MRPL has constructed a new Material Recovery Facility (MRF) with office building and all related equipment installed for handling Dry waste and Wet waste generated in the Refinery Complex, including in the Residential Townships. MRPL intends to engage the services of an agency who has requisite expertise in the field of handling the Operation & Maintenance (O & M) of MRF within Karnataka. Presently, around 2 to 3 Tons/Day of Dry & Wet waste is generated in the Refinery complex, which is to be scientifically segregated and evacuated from the premises.

In this regard, MRPL invites Expression of Interest (EOI) from interested Agencies who shall submit necessary Financial & Technical credentials for having executed such services in the past.

2.0 PROPOSED JOB DESCRIPTION:

The proposal covers the following major services:

1. Daily collection of Dry and Wet Wastes from the designated places and transportation to the MRF Plant, which located in the Refinery premises.
2. Segregation and Processing of Wastes in the MRF, Identifying End user and Evacuation of the processed waste on regular basis.
3. Operation and Maintenance of Material Recovery Facility Plant at MRPL, for a period of Two Years.

3.0 DOCUMENTS TO BE SUBMITTED ALONG WITH EoI:

1. The Interested Agency shall submit the Annual financial turnover during the previous 3 years ending 31st March.
2. The Interested Agency should have experience of having successfully executed the Operation & Maintenance of Material Recovery Facility (MRF) and disposal, in any Industry or Local bodies or Hospitals or Schools or Colleges or Universities or any other Institutions or Commercial Complex during the last 7 years. Copy of Purchase Order(s) and other related documents shall be submitted.
