1. Introduction

Mangalore Refinery and Petrochemicals Limited (MRPL) is a "Schedule –A" CPSE and a subsidiary of Oil and Natural Gas Corporation Limited (ONGC). It operates a 15 MMTPA Refinery in Mangalore, Karnataka. MRPL is a coastal refinery with Jetty/SPM facilities and is involved in the business of Refining and Marketing of Petroleum and Petrochemical products. Refinery is also connected to a product pipeline for domestic sales to hinterland.

2. Background

- 2.1 MRPL, under the brand name HiQ, has presence in transport fuel retail market in the states of Karnataka and Kerala. MRPL is aggressively pursuing direct marketing and retail network expansion in Andhra Pradesh and Maharashtra. MRPL plans to hire adequate storage facilities to move/store product coastally and expanding supply/distribution locations in Andhra Pradesh & Maharashtra.
- 2.2 In this context, MRPL is looking for/ to identify Tank Farm Operators capable of:
 - a) Undertaking Petroleum products receipts either by Marine Tankers or Rake (Tank Wagons) or by both modes (Ship &Tank Wagon).
 - b) Providing storage tanks on hire to store the products.
 - c) Delivering Petroleum products to the Tank Trucks assigned by MRPL.

3. Objective

3.1 MRPL invites expressions of interest from Tank Farm Operators interested to offer tankages for storing Petroleum Products (Aviation and Non-Aviation) as per storage requirement stated below at *Table (a)*, including receipts by coastal tankers/other modes, storage, loading/unloading/blending/additivising and other activities related with handling of petroleum.

- 3.2 The objective of this Expression of Interest (EoI) is to identify the potential applicants and their capabilities for storing/handling of Petroleum Products.
- 3.3 Based on the information submitted by interested applicants, MRPL may invite applicants to participate in the tender (competitive bidding) for hiring of storages/services.

4. Scope and Information to be submitted

- 4.1 Expression of Interest (EoI) is invited from the parties capable to offer/provide/carry out the following:
 - a) Receipts of Petroleum Products by Marine Tankers or Tank Wagons or both.
 - b) Receipts of Biofuels (Ethanol, Biodiesel, etc.) by Tank Trucks.

- c) Storages for Aviation and Non-Aviation grade Class-A/B Petroleum Products as per the requirement indicated in Table (a).
- d) Storages for Biofuels Ethanol, Biodiesel, etc.
- e) Loading of Petroleum Products in MRPL assigned Tank Trucks.
- f) Online blending of Biofuels in proportions as directed by MRPL.
- g) Storage for Additives.
- h) Online or Offline dosing of additives to Petroleum Products in proportions defined by MRPL.
- 4.2 Applicants shall submit a written confirmation of its interest stating availability of storage tanks of suitable capacity (as per Table (a)). Incase of Aviation and Non-Aviation grade Class-A/B Petroleum Products storage/tanks not being available/require conversion, applicants shall indicate the period required by the party to make the storage facility ready in all respects for handling receipts and delivery of MS, HSD, and ATF as applicable to the locations (i.e. Kakinada/Krishnapatnam and JNPT-Mumbai) in the format placed at Annexure 1.
- 4.3 Bidder shall duly fill the appropriate information sought in the table below and submit the information as Eol response along with supporting documents.
