OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

##### 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

##### 3. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

#### 4. **Generic**

- In GeM, price to be quoted inclusive of all P&F charges, Freight Charges Insurance and GST.
- Grade-1/ Superior quality pure White colour cotton Banian cloth wastes and cotton wastes shall be supplied and samples to be submitted along with the technical bid for acceptance.
- Superior quality unbleached pure white cotton Banian cloth waste of dimension minimum of 8-inch X 8-inch cut sizes, only fresh and new cloth shall be supplied. Cut pieces of dimensions smaller than 4-inch X 4-inch are not acceptable.
