### **1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### **2. Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### **3. Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

### **4. Generic**

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

### **5. Scope of Supply**

### **6. Certificates**

(g) WEIGHTS AND MEASUREMENTS: All weight and measurements/Quantity on receipt of Goods at MRPL site shall be treated as final.

(h) TRANSIT RISK Insurance upto MRPL site: at Seller scope.

(i) Material Marking: While delivering the material PO vendor shall mandatorily tag all the material supplied with Item code given by MRPL as given in the GeM enquiry documents along with the material

safety or handling data sheet.

1)Marking shall be bold (minimum letter height 5 cms) with visible ink.

2)All Documents and Material delivered to MRPL shall also contain MRPL Purchase Requisition(PR) reference number in addition to GeM reference number.

(j) Payment Terms: 100% payment will be released within ten (10) days of issue of consignee receipt-cum acceptance certificate as per GeM T &C.

(l) All Invoices shall be raised in name of Consignee only.

(J) The bidder shall agree to supply the materials with third party inspection by TPI agencies like M/s. EIL/ Toyo/ Lloyd's Register/ BV/ DNV/ TUV/ IRS/ SGS only as per technical specification. The quote from vendor shall be inclusive of TPI charges.
