It is to draw your attention to OM No. DPE/7(4)2007-Fin dated 21.08.2020 issued by Director (DPE) on "Mandatory on boarding of MSME vendors of CPSEs on TReDS Portal".

Trade Receivable e-Discounting System (TReDS) aims to address challenges faced by MSEs in delayed payments from Government buyers leading to shortfall of Working Capital. TReDS is an online electronic institutional mechanism for facilitating the financing of trade receivables of MSEs through multiple financiers. The TReDS Platform will enable discounting of invoices /bills of exchange of MSEs Seller/Contractors against large Corporates including Govt. Departments and PSUs, through an auction mechanism, to ensure prompt realization of trade receivables at competitive market rates.

On boarding of MSE vendors of CPSEs on TReDS portal is mandatory.
