SHAPOORI FALLOUHI GROUP'S Infrastructure engineering and construction company Afcons Infrastructure Ltd (AIL) is gearing up to launch its ₹5,430 crore initial public offering (IPO) on October 25.



In terms of listed equity peers, Afcons compares itself with Larsen & Toubro (L&T), IEC International (KEC), KEC International (KEC), Kalpataru Project International (KPI), and Dimp Building (DIMP).
