NORMS FOR PROCESSING INVESTOR'S SERVICE REQUESTS BY PHYSICAL SECURITIES HOLDERS OF MANGALORE REFINERY AND PETROCHEMICALS LIMITED.

As an ongoing measure to enhance the ease of doing business for investors in the securities market, The Securities and Exchange Board of India (SEBI) vide circular dated November 03, 2021 prescribed following norms:

- Common and simplified norms for processing investor service requests pertaining to furnishing of PAN, KYC and nomination details by Registrar and Transfer Agents (RTAs).
- Electronic interface for processing investor's queries, complaints, and service requests.
- Mandatory furnishing of PAN, KYC details and nomination by holders of physical securities.
- Freezing of folios without valid PAN, KYC details and nomination.
- Compulsory linking of PAN and Aadhaar by all holders of physical securities.

SEBI has introduced the following forms to standardize and simplify the processing of investor services requests by RTAs:

A) Form for availing investor services:

The Form ISR-1 is applicable for all requests to register PAN, KYC details or changes / update thereof for securities held in physical mode - **Form ISR-1.**

B) Update of signature of securities holder:

For updating the signature of the securities holder, the holder / claimant shall furnish original cancelled cheque and banker's attestation of the signature as per **Form ISR-2.**

C) Nomination:

It is mandatory for all holders of physical securities to furnish PAN, KYC and nomination details to the RTA. The details of nomination shall be furnished either through hard copy or electronic mode.
