We write to inform that the Company has received Notices from BSE Limited (BSE) and National Stock Exchange of India Limited (NSE) for non-compliance of provisions of Regulation 17 (1) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR) for not having required number of Independent Directors on the Board for the quarter ended June 2023 and consequent levy of fine as per the details indicated below:

In response to the above, the Company has already represented to the Exchanges for considering waiver of fine since MRPL is a Government Company, the power to appoint Directors including Independent Directors on its Board vests with MoP&NG, Government of India. The Company is following up with the Government from time to time for appointing required number of Directors on its Board.
