We write to inform that the Company has received notices from BSE Limited (BSE) and National Stock Exchange of India Limited (NSE) for non-compliance of provisions of Regulation 17(1), 18(1), 19, 20 and 21(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 w.r.t non-compliances in composition/ constitution of the Board and Board sub-committees for the quarter ended December 31, 2024 and consequent levy of fine as per the details indicated below:

In response to the above, the Company has already represented to the Exchanges for considering waiver of fine since MRPL being a Central Public Sector Enterprise (CPSE), the nomination of Directors on the Board of the Company is made by the Administrative Ministry, i.e., Ministry of Petroleum and Natural Gas (MoP&NG), Government of India (GoI).

We would like to inform that, MRPL has been continuously following up with MoP&NG for appointment of requisite number of Independent Directors including Women Independent Director on the Board of MRPL.
