Sub: Waiver of fine for Non-compliances of Regulation 17(1), 18(1), 19(1)/19(2) and 21 of SEBI (LODR) Regulations, 2015.

This has reference to your email letter dated 21/02/2022 intimating that company has not complied with provision of Regulations 17(1), 18(1), 19(1)/19(2) and 21 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 on compositions of Board, Audit Committee, Nomination and Remuneration Committee and Risk Management Committee for the quarter ended 31/12/2021 and in this regard, levying a fine of ₹ 11,94,160/- being ₹ 10,12,000/- as fine and ₹ 1,82,160/- towards applicable GST.

In this context, we would like to inform you that the Ministry of Petroleum and Natural Gas (MoP&NG), Government of India vide letter No.CA-31033/2/2021-PNG (39069) dated 08/11/2021 appointed 4 (Four) Independent Directors including a Woman Independent Director on the Board of MRPL. These Independent Directors were appointed on the Board of MRPL on 15/11/2021 and the Board Committees were re-constituted on 17/01/2022 to comply with SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

We would again reiterate that MRPL being a Central Public Sector Enterprise (CPSE), the nomination of Directors on the Board of the Company is made by the Administrative Ministry, i.e., Ministry of Petroleum and Natural Gas (MoP&NG), Government of India (GoI). We would further like to inform that, MRPL has been continuously following up with MoP&NG for appointment of requisite number of Independent Directors on the Board of MRPL and the same has been under active consideration with MoP&NG. Copy of latest request letter dated 21/01/2022 to MoP&NG is enclosed as **Annexure-A**.

We would further like to mention about the Policy for exemption of fines, which provides for waiver/reduction of penalty. The policy provides for waiver of fines in case of inability of the



Company to make any appointment on the Board due to pending approval from the Government (Ministry)/ Regulator or any statutory Authority.

In view of the Policy mentioned above, it is requested to waive off the fine of ₹ 11,94,160/- keeping in view the fact that MRPL being a Central Public Sector Enterprise (CPSE), Directors on the Board of the Company are appointed by the Administrative Ministry, Ministry of Petroleum and Natural Gas (MoP&NG), Government of India (GoI).

Subject: Appointment of Independent Directors on the Board of Mangalore Refinery and Petrochemicals Limited ('MRPL')

Please refer to our letters dated 18/10/2021, 12/07/2021, 06/04/2021, 03/02/2021, 02/12/2020, 08/09/2020, 29/06/2020, 19/02/2020, 08/01/2020 and 26/11/2019 requesting for appointment of requisite number of Non Official Part Time Directors (Independent Directors) on the Board of the Company ("MRPL") in compliance with Department of Public Enterprises (DPE) guidelines on Corporate Governance for CPSEs and SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015. In this context, we thankfully acknowledge the nomination of four Independent Directors by MoP&NG on the Board of MRPL.

The Board of MRPL at present comprises of only Five (5) Independent Directors along with Non - executive Chairperson nominated by Oil and Natural Gas Corporation Limited (ONGC), three functional Directors (viz., Managing Director, Director - Finance and Director - Refinery), one ONGC nominee Director, one Hindustan Petroleum Corporation Limited (HPCL) nominee Director and two Government nominee Directors.

Pursuant to Regulation 17 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ('Listing Regulations'), the composition of Board of MRPL requires 50% of Non-Official Part Time Directors (Independent Directors)

Article 128A of Articles of Association of the Company provides for appointment of maximum number of 16 Directors on the Board.

Considering the current Board constitution, additional 3 (Three) Independent Directors are

required to be appointed on the Board of MRPL to comply with the provisions of SEBI

(LODR) Regulations, 2015.

Further, pursuant to the Clause 6.1 of the DPE Guidelines, at-least one Independent Director

from the Board of the Holding Company shall be a Director on the Board of Subsidiary

Company.

It is also pertinent to mention that MRPL has been receiving notices from BSE Limited and

National Stock Exchange of India Limited imposing fines for non-compliances with the SEBI

(LODR) Regulations as regards to the requisite number of Independent Directors on the

Board of Company ("MRPL") and composition of Board Committees. We have been

requesting Stock Exchange(s) to waive off the fines as the appointment of Independent

Directors on the Board of MRPL is beyond our control as the same is being done by

Administrative Ministry i.e. Ministry of Petroleum & Natural Gas (MoP&NG).

In view of the above, your kind intervention is requested for nomination of 3 (Three) more

Independent Directors (including one Independent Director from ONGC Board) on the Board

of MRPL.
