Electronic copies of the Notice of the 29th AGM have been sent to all the members whose email IDs are registered with the Company/Depository Participant(s), unless the members have registered their request for the Physical copy of the same. The same is available on the website of the Company www.mrpl.co.in. Notice of 29th AGM have been sent to all other members at their registered address in the permitted mode. The dispatch of Notice of 29th AGM completed on 26th July, 2017.

Members are hereby informed that in compliance with the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosure requirements), Regulations 2015. The Company is extending the facility of remote e-voting provided by National Securities Depository Limited (NSDL) to its members to vote on the proposed business before the 29th AGM

The detailed instructions for e-voting are given in the Notice of the AGM. Members are requested to note the following:

- 1. The remote e-voting shall commence on Wednesday, 16th August, 2017 at 9 a.m.;
- 2. The remote e-voting shall end on Friday, 18th August, 2017 at 5 p.m.;
- 3. The remote e-voting shall not be allowed beyond 5 p.m. on 18th August, 2017;
- 4. The cut-off date for determining the eligibility to vote through remote e-voting or at the 29th AGM is 12th August, 2017;
- 5. Any person, who acquired shares of the Company and becomes a member of the Company after dispatch of the Notice of the AGM and holding shares as of the cut-off date, i.e., 12th August, 2017, may obtain the login ID and password by sending a request at evoting@nsdl.co.in. However, if a person is already registered with NSDL for remote e-voting then existing user ID and password can be used for casting vote;
- 6. The facility for voting through Ballot paper shall be made available at the 29th AGM for members who have not cast their vote through remote e-voting;
- 7. Members may note that: a) The remote e-voting module shall be disabled by NSDL beyond 5 p.m. on 18th August, 2017 and once the vote on a resolution is cast by the member, the member shall not be allowed to change it subsequently; b) The members who have cast their vote by remote e-voting prior to 29th AGM may also attend the AGM but shall not be entitled to cast their vote again; and c) A person whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date i.e. 12" August, 2017 only shall be entitled to avail facility of remote e-voting or voting at the AGM through ballot paper;
