MRPL Results

The Board of Directors of Mangalore Refinery and Petrochemicals Limited (MRPL), a subsidiary company of ONGC and Schedule "A" Mini Ratna Category I Company during its 269th Meeting held on April 26, 2025, approved it's Standalone and Consolidated financial results for the fourth quarter (Q4 FY 2024-25) and Year (FY 2024-25) ended March 31, 2025.

Major highlights for the fourth quarter (Q4 FY 2024-25):

Physical Performance (Refining):

- Achieved highest ever
 - ✓ Gross crude throughput 18.044 MMT during FY 2024-25. (Previous best was 17.116 MMT in FY 2022-23).
 - ✓ Distillate Yield of 81.93% (Prev. Best: 78.77% in FY23-24).
 - ✓ ATF production of 2.72 MMT during FY 24-25 (Prev. Best: 2.09 MMT in FY 23-24).
